Increase in registration and renewal fees - 1st April 2016

Registration fees have remained unchanged since NARCH was first founded over 6 years ago, despite increasing costs supporting our members and promoting hydrotherapy. It was agreed by a vote at the 2015 NARCH AGM to increase our joining fee to £150 and the annual renewal fee to £115.

Water Treadmill - new training and operating guidelines



For some time we have been concerned that hydrotherapists with little or no formal water treadmill training are using this method of hydrotherapy treatment. This may be because their original training did not include water treadmill training or because they have added a water treadmill some years after starting their centre with a hydrotherapy pool. As

part of our drive to continuously improve standards of treatment, NARCH has introduced new training requirements for Registered Canine Hydrotherapists operating a water treadmill.

New rules effective from April 1st 2016

All RCHs must complete the following two modules which are included in the ABC Awards Diploma in Hydrotherapy for Small Animals: email.doomails.com/t/ViewEmail/r/66CA079EBE877E792540EF23F30FEDED/630EFE0D79AAA9A70CC2E775D3CF5869

- T/504/6475 Hydrotherapy treadmill for small animals
- K/505/3147 Advanced hydrotherapy treadmill treatment for small animals

Please check with your course provider as training centres may have different course titles. Whatever course you complete, or have completed, it should satisfy the learning outcomes required for these two modules. Please check with us if you are unsure.

NARCH will be in contact with training providers to try and organise deals for members. Existing RCHs have until 31st December 2016 to comply – but please do not leave booking until the end of the year as training courses may not be available.
